Theme

Allegations against foster carers produce tremendous anxiety for all concerned. Even when not substantiated, the experience can cause foster carers to resign. Investigations can be extremely complex and delicate, involving several different agencies. What is the difference between a complaint, a concern and an allegation? What role should the fostering supervising social worker take? How do foster carer reviews and fostering panels fit into the process? What responsibility does the agency have in supporting the carers through the process of investigation and beyond? This workshop will address such questions and will be of interest to fostering social workers and managers, and members of fostering panels.
