Sound and relevant assessment is the basis for successful family placements of looked after children. This workshop will explore different models of assessment, the nature of the assessment relationship we create, and the process. Participants will identify ways of gathering evidence to demonstrate competence and consider the presentation of assessments to panels now that applicants frequently attend. This course will help participants and their agencies meet the national minimum standards.
